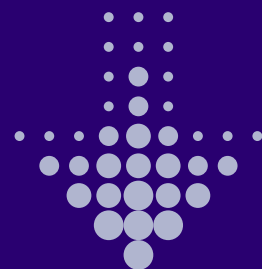

## 4 Digital Trends That Will Shape Healthcare in 2023

### Robotic Process Automation

There is a lot of potential for robotic process automation in healthcare, especially in the elimination of time-consuming, error-prone manual processes. This is a great relief for hospital administration, who can now focus on more important tasks.

### Virtual Reality bridging the training gaps!

Medical education can be done without putting patients' lives in danger, and the VR market is expected to reach \$5.1 billion by 2025<sup>1</sup>. One of the most popular uses of VR technology is in training medical professionals, who found that it can reduce pain after surgery by 24%<sup>2</sup>. Surgeons trained on computer simulations perform surgeries 29%<sup>2</sup> faster and 7<sup>2</sup> times fewer errors than their non-VR trained peers. If we sum up the possibilities, you will be surprised to know about the reduction of costs on the post-operative procedures for all 3 Ps.

### Wearables Devices (IoMT)

The market for wearable medical devices is projected to grow annually by 4.4% (CAGR 2023 - 2030)<sup>3</sup>. This is due to the increasing demand for devices that can monitor health conditions in real-time. Additionally, telehealth and remote care services are becoming more accessible with the use of sophisticated technology.

### Cyber Security preparedness

Well, by now, all the data generated through our wearable devices, all the patient data documented during our hospital visits or shared with clinical experts, and all the insurance details are stored away in the cloud safely. However, like every industry, healthcare is also vulnerable and prone to data breach. 93%<sup>4</sup> of cloud services in healthcare at a medium to high-security risk. Using strategies like security and authentication standards, the healthcare sector is learning from its peers about how to prevent patient data breaches.

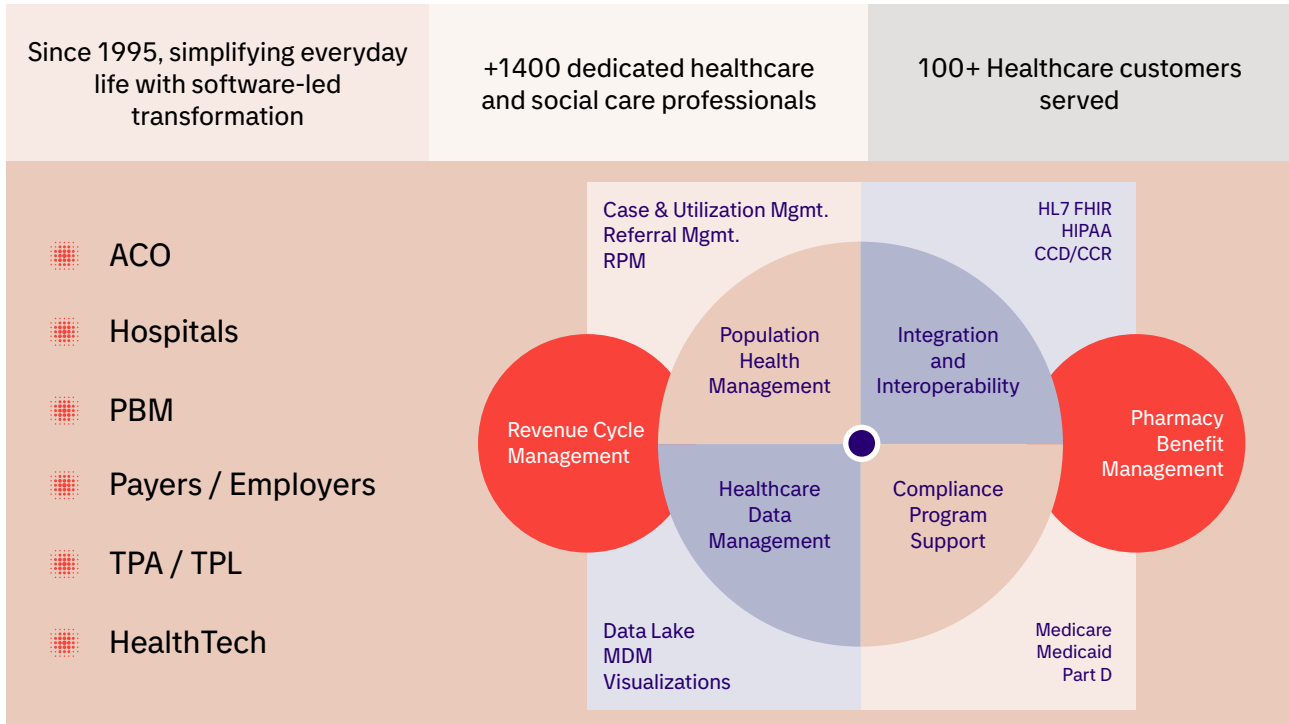
